Mikhail Myasnikovich, Chairman of the EEC Board The Strategic Directions for Developing the Eurasian Economic Integration until 2025 approved by the Heads of States have laid down a solid foundation for ensuring a new quality of economic development based on harmonizing the interests of state institutions, businesses and citizens. As the Union's key strategic planning document, the Strategy contemplates coordinating the humanitarian agenda in education, healthcare, sports, and tourism apart from traditional economic cooperation areas.

The unprecedented geoeconomic challenges defining the current context for the Eurasian Economic Union's functioning require its participants to dramatically rethink approaches for further deepening of the Eurasian economic integration and sophisticating a systematic policy to support economic growth by encouraging investment and innovation activities, creating sovereign added value chains, manufacturing and technological cooperation with a view to entirely fulfill each State's competition potential.

The emphasis on the integration shaping's human dimension enables designing the Eurasian Economic Union as an association of people, which requires the integration governing bodies to make concerted efforts for supporting the business initiative and ensuring the citizens' social welfare, as well as increasing real income, employment, and labor productivity.

The Strategy-2025 is a reliable tool for the final shaping of the common economic space, which marks its 10th anniversary this turbulent year 2022. Hence, the integration process' success and the Eurasian Economic Union's position on the global stage depend on how efficient will prove the measures and mechanisms contemplated by this strategic document.

Digital Modernization of the EAEU Agricultural Sector

The sanctions mechanisms introduced in respect of the EAEU Member States have seriously affected the sustainability of the Union's agricultural and food market from both the production and supply chain perspective, thus revealing the need to adopt active measures for developing the digitalization in the agricultural sector. Given the digital modernization peculiarities that have taken shape across the Eurasian space, the main objectives towards developing the digital economy are an accelerated development of digital infrastructure, a large-scale digitalization of the agricultural sector and basic areas of human life, as well as development of the population's digital literacy and educational system modernization with a view to train digital economy professionals.

Shaping the digital environment and relevant infrastructure will enable removing the existing barriers and ensuring the free movement of goods within the Union, as well as raising the efficiency of decision-making. Introducing alternative digital solutions will positively influence the banking sector's inclusion and transparency, enabling to increase the portfolio of financial, insurance, leasing and other services for the EAEU countries' agricultural businesses.

Joint efforts and the entire set of measures adopted in this direction will help bring the agriculture to a new development level, increase the output of competitive agricultural raw materials and products, as well as ensure the EAEU food security.

Eurasianism as an Idea for Uniting People. Outlook

The issue of the Eurasian integration ideology is in the air, however, still far from being resolved. Every former Soviet Union state generates its own national idea.

The Eurasian integration is currently considered to be purely economic, providing for the development of a common market and a common economic space. To implement the Strategic Directions for Developing the Eurasian Economic Integration until 2025, mechanisms of strategic planning, industrial cooperation promotion, development and implementation of joint investment programs and projects, collaboration in science, technology, education, healthcare, tourism and sports are envisaged. The single market is complemented by the generation of common guidelines for macroeconomic policy, coordination of industrial and agricultural policies.

At the same time, the trends of the former Soviet republic economies disintegration are yet to be overcome. In all of them, except the Republic of Belarus, the scope of mutual trade is much lower than the foreign trade with the third countries which provide for the major part of direct foreign investments. Each of the EAEU states is experiencing the strong impact of the neighboring centers of power — China, the European Union, Turkey, as well as the USA. The desired scenario for the long-term development of the EAEU 2030, which provides for establishing its own center of power, has not yet been implemented. In fact, our economy is developing as per the inertial scenario, its weight in the global and Eurasian economy continues declining.

The adverse impact of the educational and linguistic system disintegration is increasingly perceivable – the powerful cultural and spiritual intervention of external ideology systems creates new lines of tension in the society.

The economic rationality alone is obviously not enough for the further development and deepening of the EAEU. Non-economic factors that stimulate the integration processes to deepen shall be activated, and they are to be taken to a new quality level. This requires the members of the economic community to synthesize the Eurasian Idea serving both as a measure of the integration process quality and as a strategic reference point.

What is meant by the current Eurasian Idea and what is its role in strengthening economic integration within the EAEU? How shall the common cultural, historical, spiritual and linguistic heritage be updated, subordinated to the goals of inclusive development? What represents the optimal non-discriminatory state cooperation model and what ideology tools does the concept of the Greater Eurasian Partnership provide therefor?

Practical Considerations of Developing an Integrated Foreign Exchange Market in the EAEU. The Union Member States' National Currency Direct Exchange Rate Generation Mechanisms. Ways to Expand the Use of the EAEU Member States' National Currencies in Mutual Trade Settlements

Murychev Aleksandr, Vice-president for financial policy and development of economy sectors of the RSPP The objective of establishing the EAEU integrated currency market is defined by the Treaty on the Eurasian Economic Union dated May 29, 2014. The accelerated integration of the currency markets in the EAEU countries is essential for ensuring sovereignty and stabilizing the economy.

The key considerations in establishing the EAEU integrated currency market include ensuring unhindered mutual access of financial market participants – residents of the EAEU countries to each other's organized currency markets; development of mechanisms for national currency direct exchange rate generation; efficient coordination of the national (central) banks' exchange rate policy, as well as measures to increase the liquidity of the internal currency markets in the EAEU countries.

There are currently no regulatory barriers to settlements in national currencies in the EAEU States, as well as no need to take administrative measures in this direction.

To increase the number of settlements in national currencies, the utilization of financial products denominated in national currencies shall be stimulated, work shall be intensified to ensure the direct conversion of currency pairs and the establishment of a common payment space in the EAEU, to accelerate the development of mutual trade and financial flows between our countries, to reduce non-tariff barriers, as well as to actively organize the common EAEU markets, including energy markets.
