

## PRIVACY POLICY

This Privacy Policy applies to the interaction between the user of the Eurasian Economic Forum website <https://forum.eaeunion.org> (hereinafter referred to as the Event) and the Eurasian Economic Commission – the owner and the operator of the <https://forum.eaeunion.org> Event website.

### Collection and Transmitting Data

When saving (entering) the user's personal data in the Personal account, located on the website <https://forum.eaeunion.org> of the Event and/or the mobile version of the Event website, the user, of his own free will and in his own interests, gives his consent to the owner and the operator of the website, registered at the following address: 119121, Moscow, 3/5 Smolensky Boulevard, bld. 1, to process his/her personal data with the following conditions:

- the method of processing personal data is automated;
- collection and use of personal data is carried out only in case of voluntary consent of the user;
- consent is given to the processing of the following personal data: surname, name, patronymic (if any), gender, date and place of birth, passport details (citizenship, series, number, issuing authority and date of issue), registration addresses at the place of residence and actual residence, telephone numbers (working/mobile), information about the place of work/study, photo;
- collection and processing of personal data is carried out in accordance with the laws of the host state of the Commission.

The purpose of processing personal data is to perform a set of actions aimed at:

- the execution of the contract for organizing participation in the Event held by the owner and operator of the website and/or the user's pass to the territory of the Event;
- the satisfying the requirements of the laws of the host state of the Commission.

During the processing of personal data, the following actions are performed: collection, recording, verification, systematization, accumulation, storage, clarification (update, change), extraction, use, transfer (distribution, provision, access), anonymization, blocking, deletion, destruction.

Transmission of personal data to third parties is carried out:

- on the basis of the procedure and grounds established by the laws of the host state of the Commission;
- on the basis of a contract involving the user or with the user's consent.

The period during which personal data will be stored is 12 months. The operator of the website deletes the data when finishing use it.

### **User Right to Correct Data**

It is important that the data we have are accurate and up-to-date. The user can send a request for correction of his personal data by contacting the person of contact of the operator of the website via e-mail [forum@eaeunion.org](mailto:forum@eaeunion.org) or by telephone +996500855655.

### **User Right to Delete Data**

The user has the right to make a request to delete his/her personal data by sending a written notice to the operator in accordance with the procedure established by the laws of the host state of the Commission.

The operator stops processing personal data and destroys it within one (1) month from the date of receipt of withdrawal of consent to process personal data, or within the term stipulated by applicable laws, in the absence of withdrawal of this consent. From the moment the operator receives the withdrawal of consent to the process personal data, the validity and performance of the contract on the organization of participation in the Event and the right of passage to the territory of the Event shall be canceled at the same time.

Information that can be obtained from the user's device when using the website and the mobile version of the Event website:

1. Information about the location of the user's device (based on data from the Internet, mobile network operator's network and signals of the positioning systems of the mobile device (GPS/GLONASS, WiFi, Bluetooth). Purpose: informing the user when using the website and the mobile version of the website about the location of the Event site and additional services available to the user and conditioned by his/her location.
2. Information about the operating system version and the device model. Purpose: to analyze possible errors in the work and improve the website and the mobile version of the Event website.
3. Information about the user's IP address and connection point address. Purpose: to increase user safety when using the website and the mobile version of the Event website.
4. Statistical information about website usage, pages viewed, and user actions.
5. Cookies stored on the user's device. Purpose: the correct display of website content, to improve the usability of the website.

The user has the right to independently limit the provision of information by the positioning systems of the mobile device, as well as to configure the reception and blocking of cookies in the browser. Failure to locate and accept cookies will limit the functionality of the website.

### **Third-party Websites and Services**

This Privacy Policy applies only to the Event website. The operator does not control and is not responsible for the information of third parties placed on the websites to which the user can go

through the links available on the Event website. Such websites may collect or request other personal information from the user, and may engage in other activities.

This uses third-party Internet services that collect information independent of the owner and the operator of the website: Google Analytics, Yandex.Metrica, Yandex.Direct... The data they collect can be shared with other services within these organizations, they can use the data to personalize their own advertising network. User agreements are available on the websites of these organizations. There you can also refuse to have your personal data be collected.

We have no control over such third-party websites and are not responsible for their privacy policies. After navigating from the Event website, we advise users to review the security policies of all websites they visit.

We do not share personal data with other organizations or services not listed in this Privacy Policy. The only exception is the transmission of information when legally required by state authorities authorized to carry out such actions.

### **Links to Other Websites**

Our website may contain links to other websites that are not operated by us. We are not responsible for their content. We encourage users to read the privacy policy of each website they visit, if there is one.

### **Data Protection**

1. The operator shall use appropriate legal, organizational and technical measures to ensure the integrity and protection of data collected through the website and the mobile version of the Event website.
2. The operator restricts access to the user's personal information only to those employees, agents, contractors and other involved persons who require this information to perform their job duties. They handle user personal information solely in accordance with our instructions and are also obligated to keep it confidential.

### **Changes to This Privacy Policy**

The operator reserves the right to change this Privacy Policy from time to time as deemed necessary by the operator or required by law.

### **Feedback**

If user has any questions about the Privacy Policy or data processing, he/she may contact the operator. The operator's contacts are listed on the official website in the "Contact Us" section.

All requests on issues of confidentiality and processing of personal data are transferred to a special department, whose staff evaluates them and tries to find a solution to the problem. If a problem requires more detailed consideration, the staff can contact the user for more information.

Senders of such non-standard requests are given a detailed response.

If the user does not agree with this Privacy Policy, he/she cannot use the services of the website and/or the mobile version of the Event website. In this case, the user shall refrain from visiting the website and/or using the mobile version of the Event website.
