

# RULES FOR THE USE OF MATERIALS POSTED ON THE EURASIAN ECONOMIC FORUM WEBSITE

## **1. General Provisions**

1.1. These rules determine the order and conditions of use of information, news and other materials posted on the website <https://forum.eaeunion.org/> owned by the Eurasian Economic Commission – the Forum Operator (hereinafter referred to as the Operator).

The website of the Eurasian Economic Forum event (hereinafter referred to as the Website): <https://forum.eaeunion.org/>.

1.2. Any materials posted on the Website are copyrighted. The Operator's rights to these materials are protected by exclusive rights to the results of intellectual activity laws.

1.3. The use of materials posted on the Operator's Website is possible only in the cases expressly provided for in Clauses 2.2.1. – 2.2.3. of these rules.

1.4. These rules apply to the following users: news agencies, electronic and print media, individuals and legal entities (hereinafter referred to as the Users).

## **2. Use of Materials. Types of Use**

2.1. The use of materials means reproduction, distribution, public demonstration, broadcasting, cable transmission, translation, processing, communication to the public and other types of use as provided for by the applicable laws of the host state of the Commission.

2.2. Use on a gratuitous basis:

2.2.1. Any materials of the Operator can be used without written consent of the Operator and on a gratuitous basis, provided that the user is an individual and such use is for personal purposes only.

2.2.2. The use of information text materials, photo, graphic, video, audio and other materials posted on the Forum Website belonging to the Operator by charitable organizations, as well as by any educational institutions on a gratuitous basis is possible without obtaining written permission (consent) from the Operator.

2.2.3. News, photo, graphic, video, audio and other materials posted on the Forum Website and belonging to the Operator can be used by any Users without obtaining a written permission of the Operator and on a gratuitous basis, provided that these materials are not the main content of the product in which they are used. That is, in addition to the Operator's news, the User's resources shall contain additional content (original content or content from other news resources not belonging to the Operator). In this case, Users are obliged in each case of use of news to provide a link to the source and a hyperlink to the website from which the materials were borrowed.

2.2.4. Making any changes and/or additions to the Operator's materials, as well as any reworking of the materials is possible if it does not distort the meaning of the materials.

2.3. Other types of use

2.3.1. If it is necessary to use photo, graphic, video, audio, or other materials posted on the Forum Website belonging to third parties, Users shall contact the copyright holders of such materials.

### **3. Responsibilities of Users when Using the Materials**

3.1. When using the Operator's materials for any purpose other than personal use, link to the Operator's website is mandatory:

3.1.1. In printed publications or other forms on tangible media, Users are obliged to indicate the source – the website of the Eurasian Economic Forum event (<https://forum.eaeunion.org/>) in each case of use of materials.

3.1.2. In the Internet or other forms of electronic use, Users are obliged to place a hyperlink to the Website – the website of the Eurasian Economic Forum event (<https://forum.eaeunion.org/>) in each case of use of the materials.

3.1.3. The link to the source or the hyperlink indicated in Clauses 3.1.1. and 3.1.2. of these rules shall be placed by the User at the beginning of the used text material, as well as directly under the used audio, video, photo material, graphic material of the Operator.

3.1.4. Use of the Operator's materials obtained from secondary sources is possible only with the link to these sources.

3.2. When using the Operator's materials, reworking of the original text is allowed, as long as it does not distort the meaning of the materials.

Reducing material is possible only if it does not lead to a distortion of its meaning. In this case, Users are solely responsible for distorting the meaning of the materials.

3.3. When using the information and news materials of the Operator the Users shall not indicate on their websites and RSS feeds the time of release of information and news materials identical or earlier than the time of their release on the Operator's website.

4. The Operator reserves the right to change these rules unilaterally at any time without notice to Users. Any changes will be posted on the Operator's Website. Changes shall become effective as soon as they are posted on the Website.

## **5. Liability for Unauthorized Use of Materials**

5.1. Any unauthorized use of the Website materials is a violation of Operator's and/or third parties' rights and entails criminal, civil and other liability, stipulated by the applicable laws of the host state of the Commission.

5.2. In case of claims to the Operator from any third parties whose rights are violated by the unlawful actions of the User, as well as in case of orders, warnings and other acts of the authorized state authorities, the involvement of the Operator in a lawsuit as a result of unlawful actions of the User, the User compensates all losses incurred by the Operator thereby.
